Cox v. Stern, 170 111. 442, 48 N. E 900, 62 Am. St Rep. 355; Hays v. Loomis, 54 111. 18. An affidavit is a written declaration under oath, made without notice to the adverse party. Code Civ. Proc. Cal.<sup>1</sup>

**According to Mbodji v. The State of Ohio:**

“A citizen may file an affidavit charging the offense committed with a reviewing official for the purpose of review to determine if a complaint should be filed by the prosecuting attorney.” A 'reviewing official' is a judge, a prosecuting attorney, or a magistrate.”<sup>2</sup>

## Forward:

Mr. Kevin Byrd & Ms. Alexandra Wilson ("the couple") for *many years* worked to develop *several* organizations & publications (*see pages 62-93*) to benefit *the public and Kern River Valley residents*. Ms. Wilson had been *hitchhiking the country with her guitar* over 13 years documenting & *learning to live according to* Native American ethnobotanical & *traditional wild living skills due to her personal religious beliefs*, & she & Mr. Byrd became a couple in 2012, when they would begin *traveling, writing songs, street performing, & continuing to develop the websites & publications while "homeless for humanity"* until 2015, at which time they began researching a *legal process* they learned about from *several Kern River Valley residents- a legal process which exists in all 50 States* (its embedded into The Constitution) called *adverse possession*.

## A Brief Overview of Adverse Possession Laws:

*The process of establishing an adverse possession claim in California is written within the CALIFORNIA CODE OF CIVIL PROCEDURE sections 315-330<sup>3</sup> (see page 232-237). The process enables a person:*

- 1. to take possession of a physically abandoned & neglected property,*
- 2. to enclose (as in "fencing"), make improvements upon, & cultivate the land,*
- 3. to get property taxes switched into one's name & to pay those taxes,*
- 4. then. after five years of adhering to this procedure, then requesting a hearing to show the judge that statutory requirements have been fulfilled, to obtain the title deed to the property following due process of law (see "5<sup>th</sup> Amendment" on page 261).*

For a title holder *to remove someone who has taken lawful possession of a property they had left neglected to the point where it had been given back over to nature*, they may evict the possessor via *performing an EVICTION (see pages 249-251)* so they have time to gather their belongings & relocate; if the occupant had put a significant amount of labor & resources into renovating the property, the occupant *may* seek to place a *lien* on the property in order to receive compensation for renovation costs. A person seeking *to perfect an adverse possession claim via following the CODE OF CIVIL PROCEDURE in this manner* cannot be tried with *criminal trespass, theft, etc. by the title holder*, as the person seeking "to fix up & homestead a neglected, abandoned property" is not in derogation of any law by doing so, but *rather they are acting in accordance with the law*. The process of adverse possession is designed to deter property owners from *leaving their properties "neglected & falling apart in the middle of town"*, *and* to safeguard the public from having *perfectly useful homes go to waste & turn to community hazards*.

## Brief Overview of Case:

Both Mr. Byrd and Ms. Wilson discovered 2232 Commercial Ave. in damaged & neglected conditions (see pages 8-32); the title holders (Mr. Jon & Cheryl Ross) never resided at the property nor did they perform any upkeep, thus allowing nature to take the property back over. So Mr. Byrd & Ms. Wilson moved in & performed approximately six months of labor making improvements. Mr. Byrd spent thousands of dollars on such improvements. The couple also cultivated the land & grew a wide variety of different crops (see pages 118-160). They received mail at the address (see pages 59-60), had the electricity & water utilities turned on, & also the internet turned on in Mr. Byrd's name. Mr. Byrd also received his first property tax bill in his name (page 238), & had spoken the Kern County Tax-Recorder regarding "securing his first payment" at the beginning of the upcoming month. Mr. Byrd's monthly income is sufficient to cover property taxes; Mr. Byrd was *HOLDER IN DUE COURSE* of the title deed for 2232 Commercial Ave. **on 5-11-2016** (see page 239), on which day **5 Kern County Sheriff's Deputies trespassed onto the property without a warrant, refused to witness Mr. Byrd's claim papers** (see pages 196-199 & 247-253) **performed an illegal search & seizure which amounted to the theft of Mr. Byrd's smartphone** (247-258), **& then performed a false arrest on the couple for "trespassing"** (page 254). **The couple was forced to leave most of their belongings behind, as officers warned the couple that if they "step foot back on the property", that they would "be arrested". The couple was "put out onto the streets & made homeless" without their smartphone, & they were not permitted to retrieve most of their possessions as Kern Deputies threatened to arrest the couple if they returned to the property, causing the couple to lose thousands of dollars worth of property including property belonging to the organizations they own & operate.**

Following the series of injustices which followed (see pages 208-215), the couple fled Kern County for their safety, forced by circumstance to leave most of their belongings behind; since that time Ms. Wilson wrote this "Affidavit for a Citizen's Arrest" which contains evidence that Mr. Byrd, Ms. Wilson, & Ms. Rachel Smith (see pages 161-199, 231-239, & 314) all had their civil rights violated, that all of their lives have become severely endangered as the direct result of Officers' (& others') actions, & that all three are due restitution to recover from damages, loss of property, & personal injuries sustained. Ms. Wilson has compiled a "Redress of Grievances" (beginning on page 271) to not only gain restitution, but also in order to implement training & new protocol for all public officials specifically "to provide equal protections of the laws to title holders & to those who are seeking to perfect a lawful adverse possession claim".

This AFFIDAVIT mostly provides specific details as to how the Plaintiffs' civil rights were violated by officers who commit crimes under color of law.

## Introduction:

Sometime around the end of *July* 2015, Mr. Kevin Byrd & Ms. Alexandra “Distance” Wilson (collectively referred to as “the couple” throughout this testimony) learned that the property located at 2232 Commercial Ave. in Lake Isabella, California had been physically abandoned for many years. They were told this by local friends (“Rudy & Liz”) who reside across the street, who claimed that “the house had just been sitting there”, that “no one had been living in it for years”, & that “the previous occupants did not take care of it” & had left it in “bad condition”.

Rudy & Liz had known the couple for years, as Rudy had first picked up Mr. Byrd and Ms. Wilson while they were hitchhiking to a Native American pow wow with their guitar around 2012. They had visited on many occasions since, including to Rudy & Liz's home where at times they had been offered showers and to be able to do laundry among conversations. The group would hang out & get to know one another, & they all shared similar passions including gardening and learning from Native Americans & Native American skills. Rudy & Liz liked the textbook Ms. Wilson had put together with local Army Veteran Mr. Richard “Lonewolf” Legan regarding ethnobotany & Native American traditional wild living skills<sup>4</sup>, & also they had shown interest in the several organizations the couple had designed to operate locally. The couple was working on several future publications at the time, & also several websites designed to benefit the general public (see EVENT #5). They all agreed that “having a place to be to publish the books and continue lifting off the organizations” would be beneficial to the couple and the community.

The couple had expressed they were looking for “an abandoned property to move into” because they'd recently learned about “the legal process to performing an adverse possession on a physically abandoned & dilapidated property” from more than one local source. The couple then performed independent research on this topic to learn the procedure. They required “a place to be” in order to “get on their feet” and “plant a garden”. At the time, the couple had been “working full-time building the websites & publications” and via “street performing with a guitar to keep the projects moving forward”.

Due to their many years “on the road” performing and developing the organizations, the couple was physically exhausted, & the local shelter in Bakersfield was full, also they were carrying sensitive & important data on their computer which was engendered via them being vulnerable & “on the streets”. The couple was told that there “was no room” at the local shelter in Bakersfield, and besides this the couple was looking to homestead due to their religious beliefs, which is not something the local shelter was able to help provide them with according to what they had been told by authorities at the shelter.

## Introduction to *Wild Willpower PAC* vs. *COUNTY OF KERN*

The couple had many friends & “fans of their work” at the time, *but they didn't have a home*, so they saw *learning of Adverse Possession* as “a great blessing” because it could help them “get off the streets”, “grow food”, & “get their lives together”. They expressed plans “to grow enough food to feed themselves *and* other community members” to neighbors, friends, & family members. “*Adverse Possession coupled with Homesteading on an uncared for property*” seemed to the couple like “an ideal way” to *have a place to be* in such way which would benefit themselves *and* the community”.

Up to that point they'd been documenting the skills of a local disabled U.S. Army Veteran (& teacher) who claimed he hadn't been receiving his “due military benefits”, so they volunteered to help him via *finding him a lawyer, assisting with online correspondence, purchasing meals & running errands for he & his family when able, & also via “producing educational publications”* via documenting his rare skillsets. The couple had been *documenting Mr. Legan's skills* in order to *learn for personal benefit “so they would have the knowledge necessary to live according to their beliefs”*, and *also* for the sake of “designing & printing publications to pass the valuable knowledge he teaches *on* to humanity”. The couple had plans to publish the book through their *Civil Political Action Committee* they were developing as well (*see EVENT #5 & www.WildWillpower.org for details*).

On 8-31-2016, *after* being told by Rudy that he “had tried to contact the owner of 2232 Commercial Ave. (Mr. Jon Ross) several times”, but that he “had not heard back from him”, the couple *documented the conditions* of the neglected, dilapidated, & *physically abandoned* property located at 2232 Commercial Avenue including *the hazards it was imposing upon the surrounding properties*. The couple planned to *write a book about how to lawfully claim a physically abandoned & neglected property for the purpose of homesteading* since the day they moved in, *but their documentation got written into this Affidavit* which was written between 5-13-2016, & it was *printed & bound in its final form* on The Fourth of July, 2016, with intent to file it at the Federal District Courthouse in Bakersfield, California on Wednesday, 7-6-2016, one day before their scheduled *first appearance* regarding the fabricated “trespassing” charge (*pages 186-205 & 231-270*) at the Ridgecrest Superior Courthouse.

*“Wherein I have no degree in law, but am however a student in life & am dedicated in service to humanity, & whereas I contacted many lawyers & law groups to acquire legal aid but had no return as of yet, I ask the courts to read what is written, & judge according to what is true & right, & not to cast down this case based upon any stipulation to which I am not accredited to have learned about. Thank you, Your Honour.”*

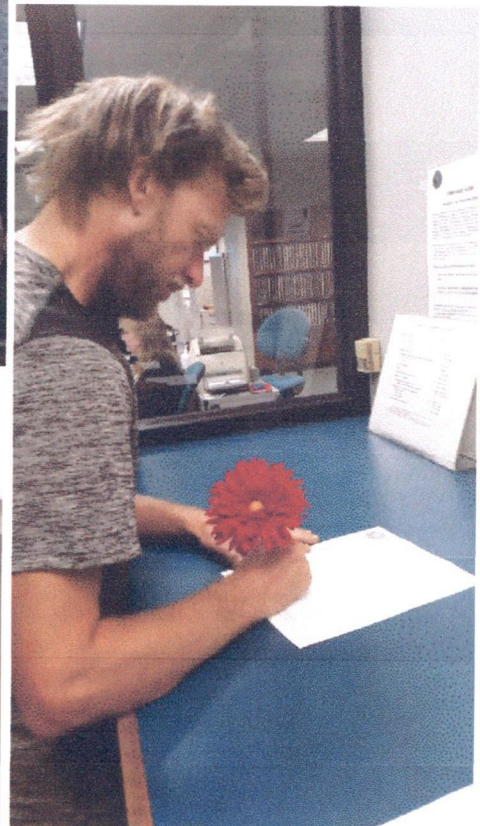
On Friday, 9-4-2015, Mr. Byrd filed *an initial filing of* a DECLARATION OF CLAIM OF ADVERSE POSSESSION using paperwork he received *from* the clerk upon request. Several "publicly beneficial purposes" for utilizing the property were indicated on the DECLARATION *just in case* Wild Willpower progressed their work *enough* in order to EMINENT DOMAIN the property on a later date for use as a home base for *Kern River Wildharvesting Cooperative*.

**Mr. Byrd's initial filing of the DECLARATION OF CLAIM OF ADVERSE POSSESSION asserted his *Right to seek to Claim a physically neglected, abandoned, & uncared for property* in order to seek to perfect a lawful:**

**1.) *Quiet title claim upon the real property following due process, statutory requirements (improvements & payments of taxes), & other considerations (ie community service).***

**2.) *A negotiation with the title holder, should the holder seek to challenge the Claim, or to make arrangements with the title holder in order to transfer the deed to the Claimant by some other means (ie purchase, easement, etc.).***

Mr. Byrd asserted his *right* to seek to lawfully claim the abandoned property. Because the title holders had left it uncared for *in negligence*, they are required by law to serve an *EVICTON NOTICE* to Mr. Byrd if they choose to remove him from the property. This part of the law is designed to give “lawful possessors” ample time to make arrangements *to move off the property or to negotiate arrangements with the title holder.*

### **“EVICTON”**

**Dispossession by process of law ; the act of depriving a person of the possession of lands which he has held, in pursuance of the judgment of a court.** Reasonerv. Edmundson, 5 Ind. 395; Cowdrey v. Coit, 44 N. Y. 392, 4 Am. Rep. 690; HomeLife Ins. Co. v. Sherman, 46 N. Y. 372. **Technically, the dispossession must be by judgment of law; if otherwise, it is an ouster.** Mitchell v. Warner, 5 Conn. 497. In the civil law. **The abandonment which one is obliged to make of a thing, in pursuance of a sentence by which he is condemned to do so.** Poth. Contr. Sale. pt. 2, c.1,<sup>1</sup>

The primary reason a state would give [credence] to possessors is to reward the possessor's labor & attempts to discover unused property. American law draws its origins from English law, which assumes that ***property unused is property wasted***. Thus, giving credence to possessors *who are acting in good faith* ensures no property will go unused, allowing the community to produce at full capacity. Filling out an adverse possession form will protect the possessor from charges of criminal trespass, however the true owner can still ask the police to *evict* the possessor.<sup>2</sup>

## More About Adverse Possession:

Based upon *statutory requirements & principles under Common Law*, the Claimant is Declaring:

- “Yes this property *is* physically abandoned *and* showing signs of damage which will *worsen* if the property faces further neglect”.
- “Yes I will *physically reside at and make improvements upon* this property. I will not do this in secret, *but rather publicly*.”
- “Yes I will pay property taxes for the next 5 years, at which point I will request a hearing in order to perfect my *Quiet Title Claim*.”

### Frequently Asked Question:

“Don't you have to pay 5 years of taxes *before* you can claim the property?”

#### Answer:

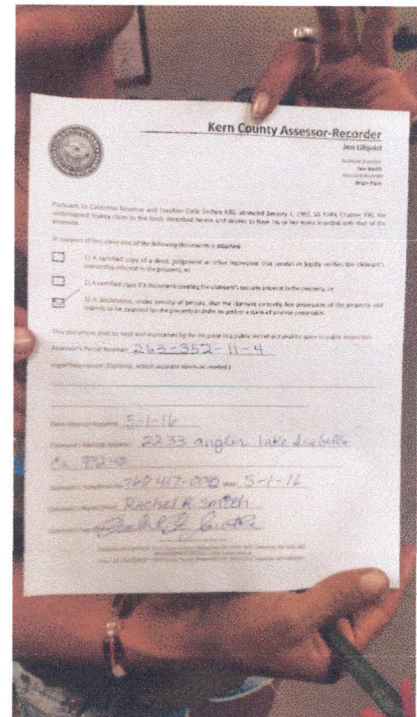
No. The Claimant must *physically live on the property* during this time, after which time they may request a hearing to show the judge *evidence that they have fulfilled requirements of the law (i.e. photo evidence, testimonies, proof of property tax receipts- see pages 231-243, etc.)* in order to have the Court grant them a *quiet title claim*.

### What is A Quiet Title Claim?

“A proceeding to establish an individual's right to ownership of real property against one or more adverse claimants.”

An action to quiet title is a lawsuit filed to establish ownership of real property (*land and buildings affixed to land*). The plaintiff in a quiet title action seeks a court order that prevents respondent from making any subsequent claim to the property. Quiet title actions are necessary because real estate may change hands often, & it is not always easy to determine who has title to the property.

A quiet title suit is also called a suit to remove a cloud. A cloud is any claim or potential claim to ownership of the property<sup>3</sup>

The couple was documenting *everything* so the "wildharvesting cooperative" could be replicated around the world "to help the economy *and* ecology". 2232 Commercial Ave. was being developed to *eventually* become a *home base* from where the cooperative could operate from. After years of seeking funding to model their organization, the couple was informed that "adverse possession claims" *had worked* for other people in the area, & that is was a "low budget solution" for grassroots projects. In no way did the couple think they were doing anything *illegal* by possessing 2232 Commercial Ave.; *rather the contrary*. 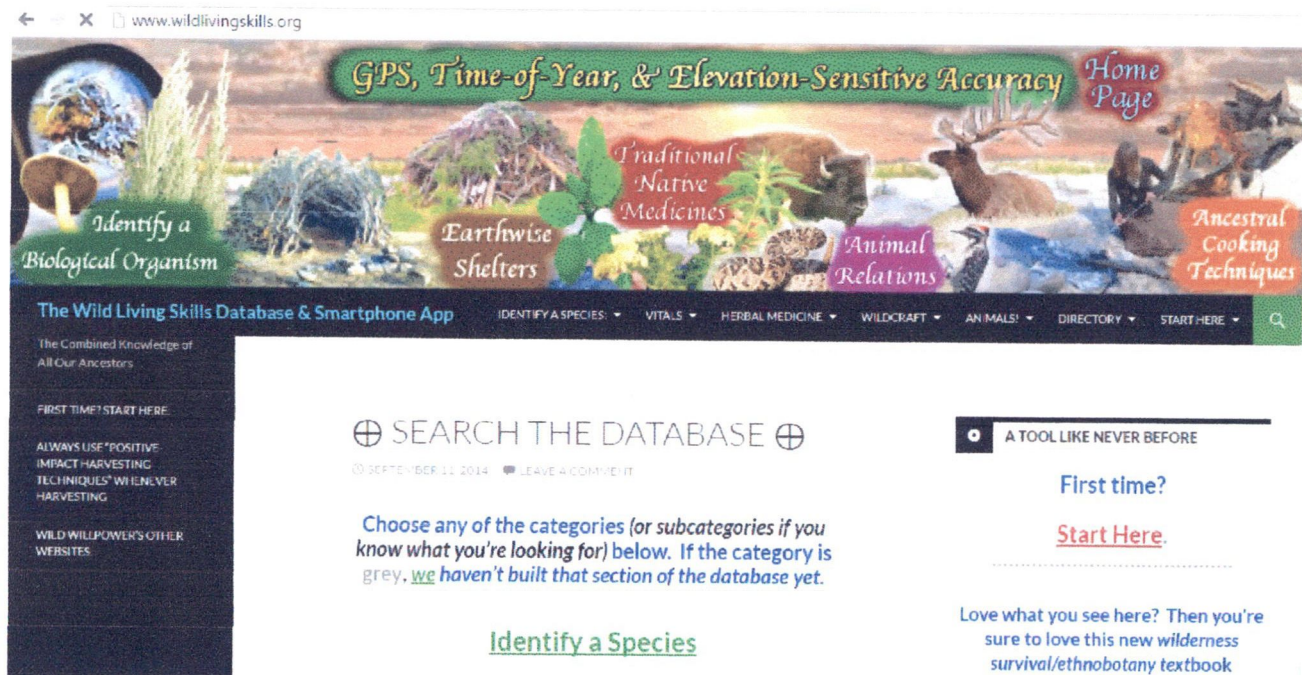

**www.WildLivingSkills.org:** "The Wild Living Skills Database & Smartphone App" in-the-making. This website being designed "to co-process the user's GPS location, time-of-year, & elevation" so that *anybody* will be able to identify any species of lichen, plant, mushroom, tree, moss, shrub, grass, or algae within only 3-5 questions. The *responsive* site will work with smartphones *or* desktop computers, & is being compiled "for noncommercial purposes, *to help all people*, using The First Amendment". The site contains *touch-&-view glossary terms with photos (rollover-&-view for desktop computers)* in order to make identification easier. Average number of questions required to identify a species using *books* is about 20 questions, whereas *because* this site co-processes the user's location with the time of year & elevation, *its reduce to only about 5*.

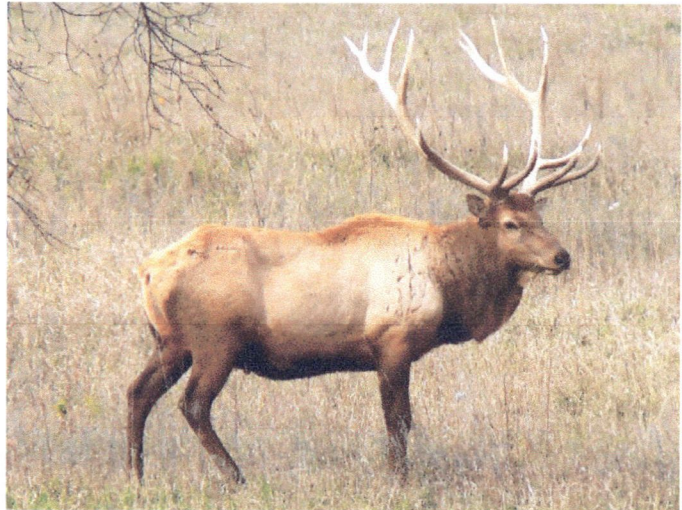

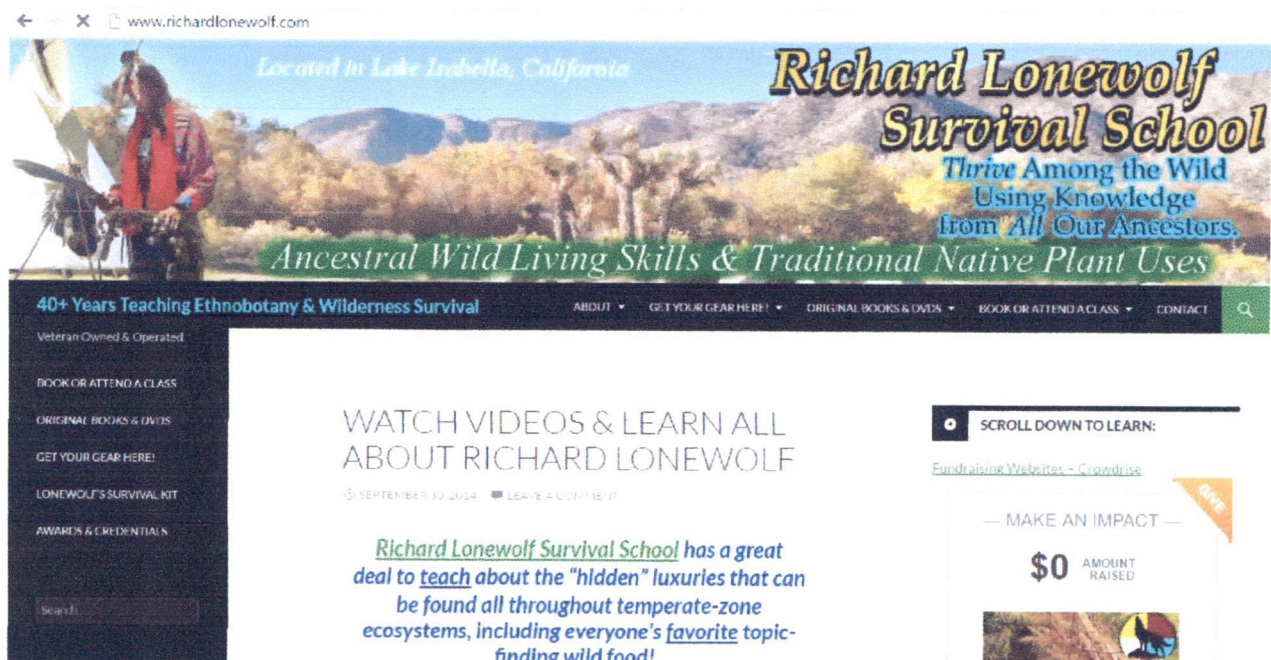

**www.RichardLonewolf.com:** The home page for "Richard Lonewolf Survival School" was developed between 2010 & 2016 by Ms. Wilson alongside ethnobotany & wilderness survival expert Richard "Lonewolf" Legan a local *longtime ethnobotany & wild living skills instructor from the Kern River Valley*. Lonewolf was disabled U.S. Army Veteran who hadn't been receiving his due military benefits, while having taught "Ethnobotany, Wilderness Survival, & Traditional Native American Wild Living Skills" his entire life in this area to students ranging from kindergartners to church groups to U.S. military units- *California State Colleges & Universities, Kern Chapter California Native Plant Society*, & many other students & organizations. Both Mr. Byrd and Ms. Wilson "peaceably assembled" this website together "as a mode of First Amendment expression" in order to "set the tone" for Wild Willpower's works, *in hopes to help document & broadcast traditional skills with other Native American traditional life skills instructors in the future as well*. 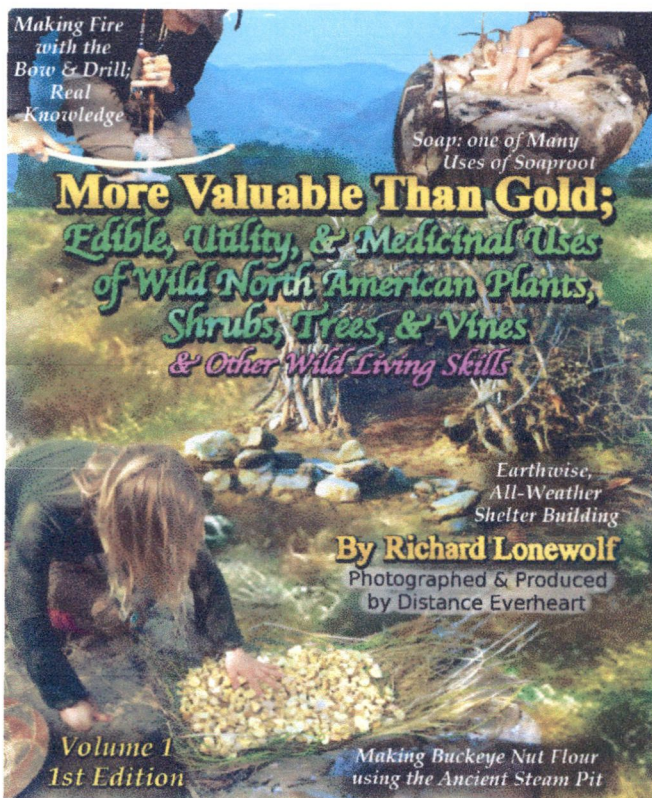

The work between Wild Willpower & Richard Lonewolf Survival School *was stopped short* due to criminal accusations which were filed against Mr. Legan in April. Albeit damaging & unexpected to Mr. Byrd & Ms. Wilson's reputation as the accusations *are* very serious, the couple was unaware of *any* of the circumstances involved with the issue- *which came as a surprise, shock, & disappointment*- so they began redeveloping Wild Willpower to create some level of distance from the situation, however as the organization was *built* around the skillsets Mr. Legan teaches, there are indivisible elements embedded throughout [www.WildWillpower.org](http://www.WildWillpower.org) & supporting websites. 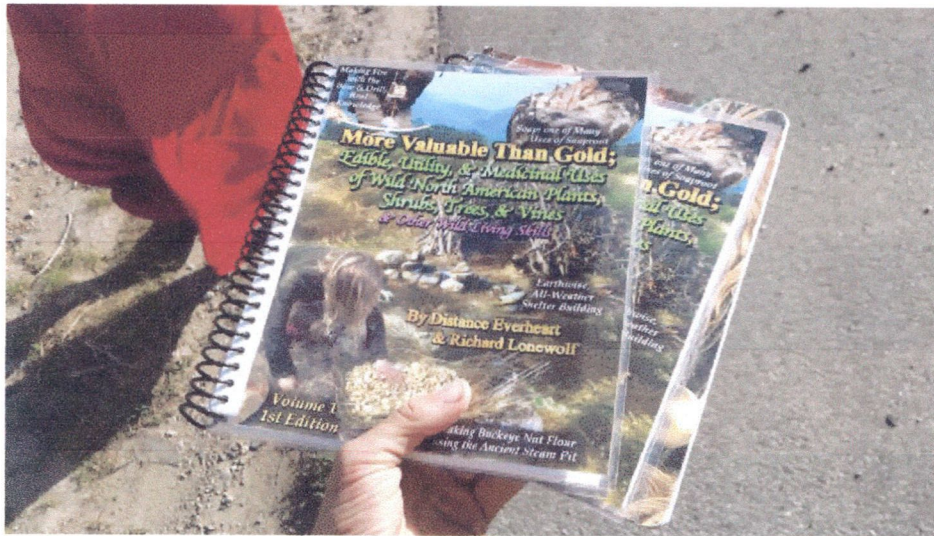
Besides “books, DVDs, survival manuals, & a website”, Wild Willpower PAC *also* designed & printed for Mr. Legan *business cards, fliers, posters, & a ~3' x 5' banner*. Throughout the winter, Mr. Byrd & Ms. Wilson utilized their “new house” to produce publications & media to help Mr. Legan promote his new school & get “lifted off”. Mr. Byrd & Ms. Wilson volunteered *years* up to this point toward getting Mr. Legan's school & publications prepared, & so “having a place to be” thanks to “abandoned properties & adverse possession” was turning out to be *a lifesaver*. As “Lonewolf” had claimed to be “a disabled veteran not receiving his due benefits”, & because Mr. Byrd *and* Ms. Wilson saw how the poverty was adversely affecting Mr. Legan's life *and the lives of his children*, and because of the *importance* of the skillsets Mr. Legan was offering which hadn't been properly recorded, Mr. Byrd *and* Ms. Wilson saw it as their *duty* to try to make this situation better. ## **PETITION #1: Enact “*Civilian Restoration Corps.*” To Create “A Public Works Program” Which *Pays* People “To Plant Free Food & Herbal Medicine” Throughout Towns & Cities of All Sizes**

"Civilian Restoration Corps." is a public works program designed to allocate resources (i.e. "Homesteading Starter Kits", solar panels, etc.) and training necessary to create millions of jobs "planting free food & herbal medicine everywhere" (useful plants & trees using traditional permaculture techniques from around the world, with an emphasis on planting native & heirloom flora & fauna) throughout towns & cities of all sizes- thus replacing "decoratives & water-suckers" (i.e. lawns) throughout urban and rural town areas. Also Civilian Restoration Corps. will be charged with creating "a completely energy-independent, wisely-built system" designed "to power the peoples' energy needs" without creating "unnecessary amounts of perpetual dependence upon the need to extract combustible fuel". 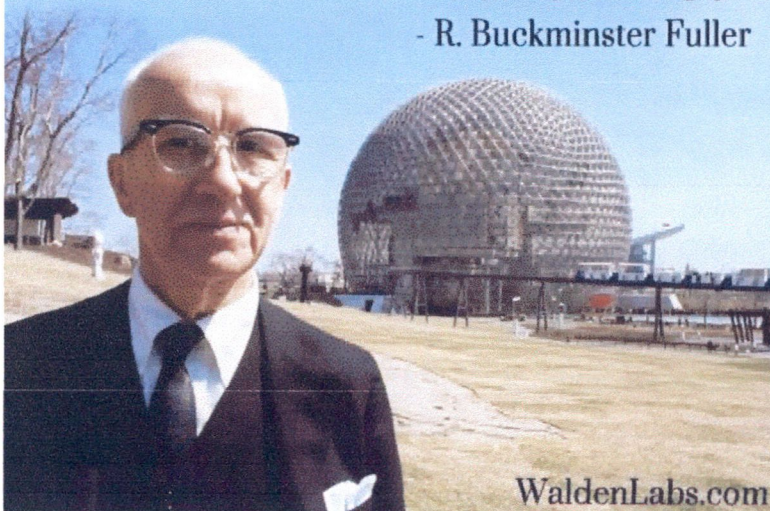

**#1.) Statistics:**

- There are approximately **3.5 million homeless people in the U.S.**[1]
- Approximately **50,000 veterans are homeless**[2], & about **~1.4 million veterans considered "at risk of homelessness"** due to *poverty, lack of support networks, & dismal living conditions in overcrowded or substandard housing.* [3]
- **1 in 2 Americans have fallen into poverty or are struggling to live on low incomes.**
- **Since 2007, banks have foreclosed around eight million homes, averaging 10,000 per month!**
- **There are 18.5 million abandoned properties just "sitting there" throughout towns & cities of all sizes (that banks foreclosed on or people died in & the family left it abandoned, mismanaged estates). These properties are basically going to rot, get fixed up by real estate agencies & rented back out to the people, OR we can choose to manage these resources wisely via creating**



## ***Real Housing Solutions For People Coupled With An En Masse Homesteading Movement***

The National Economic and Social Rights Initiative along with Amnesty International are asking the U.S. to step up its efforts to address the foreclosure crisis, including by giving serious consideration to the growing call for a foreclosure moratorium *and* other forms of relief for those at risk, *and* establishing a housing finance system that fulfills human rights obligations.[4]

### **#2.) The Proposal:**

1. To charter a federal program designed “to map all properties which have been *physically abandoned* for two or more years, *TAKE* such properties using EMINENT DOMAIN, & then to *fund* basic repairs needed (*ie electricity, plumbing, insulation, foundation, etc.*)”. Each such parcel is entered into a *database*, & Citizens may *opt* to “Homestead” at any Human Resources Department office in order to *select a reclaimed property from within the area* for the purpose of “growing enough food to feed themselves *and* others”. After 5 years of occupation *and* fulfilling obligation, paying taxes, *and* maintaining all *non-arbitrary & capricious* health & safety code regulations compliances, Claimant gains *Title* to the real property.
2. To provide educational material *alongside* ”Homesteading Starter Kits”, *which include a variety of “heirloom seeds” in “kits” coupled with seeds for “plants which require similar care” &/or “companion plants”*. Kits include: “*Full Sunlight, Low Water*” kit, “*Leafy Greens (& herbs & spices of similar care)*”, “*The 3 Sisters*”, “*Cold Frame Plants*”, & *more*). Kit instructions *also* contain “*highly-efficient growing techniques researched from around the world*”.

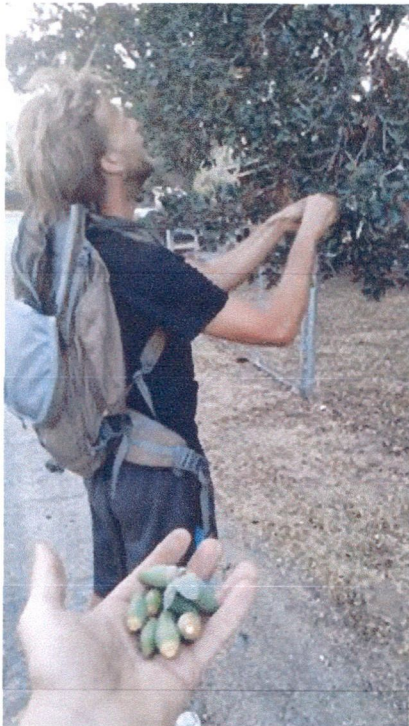

## Making The Knowledge Applicable; *Performing R & D For Lifting Kern River Wildharvesting Cooperative*

Something the couple *discovered* while learning these skills is that “although *many* people are *interested* in ethnobotany & wilderness survival, *most* people do not have the time or money to afford *the luxury of being able to take classes- especially if these skills don't appear applicable to people.*

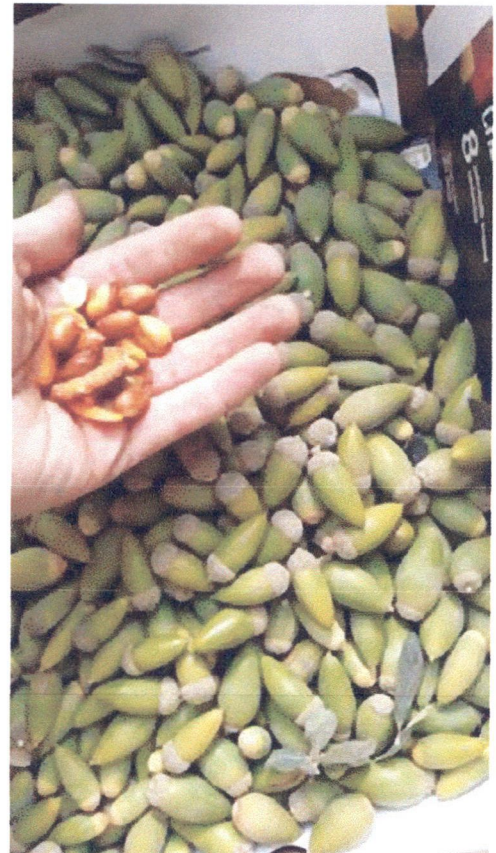
In order to model “what a Wildharvesting Cooperative *looks like*”, the couple needed to broadcast “how to make acorn flour from acorns” in order to orchestrate “an en masse movement”. After all, *acorns are an abundant crop*, with measured yields of 500 to 1,000 pounds per large tree! (Heizer & Elsasser 1980:91-101<sup>2</sup>) The couple had plans “to teach the public *how to process acorn meat into flour* using a 20 minute traditional technique”,

The blue powder on the outside of the large nuts is yeast.



Mr. Byrd & Ms. Wilson collected about a backpack-full of acorns per day— which could make *many* loaves of bread!

## Cleaning the Chimney

To prevent a creosote fire<sup>3</sup>, the couple borrowed a *chimney sweep* from their friend & Historical Society member Hal Chiprin in order to *clean the chimney & stove pipe*, which helped in *drying acorns for storage*.

*Prickly Pear Cacti are a common sight in the Kern River Valley & many other places throughout California & the desert southwest.*

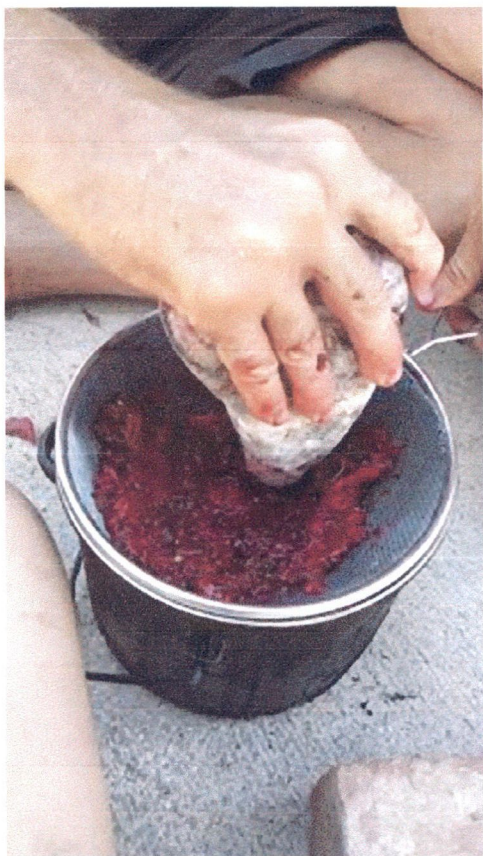

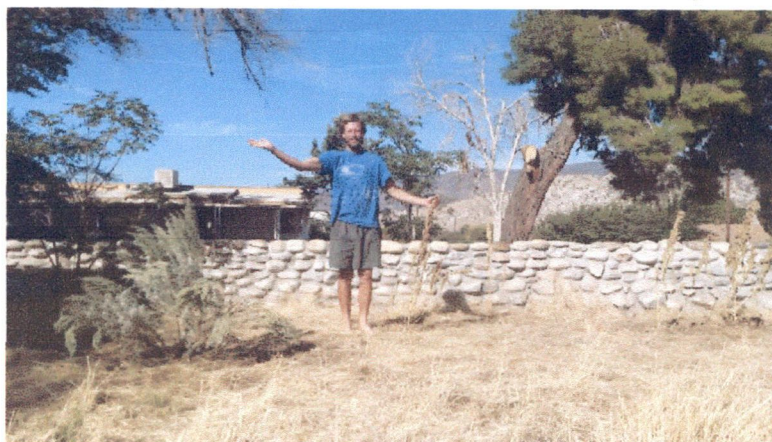

## **They Planted *Useful* “Drought-Tolerant *Native* Plants”:**

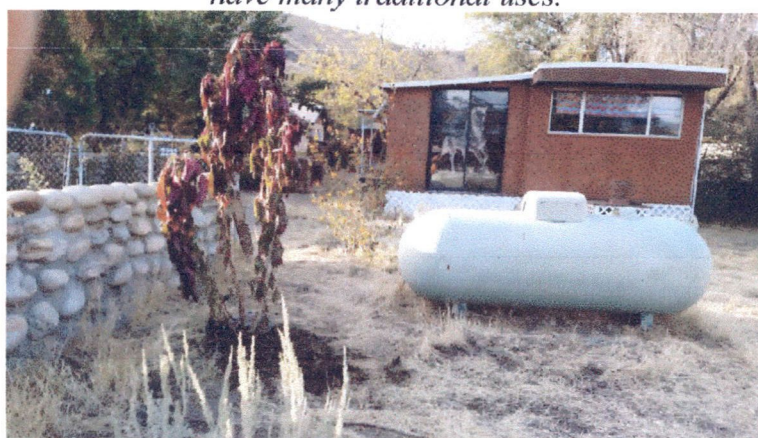
They planted several *very useful plants* which require “very little water”.

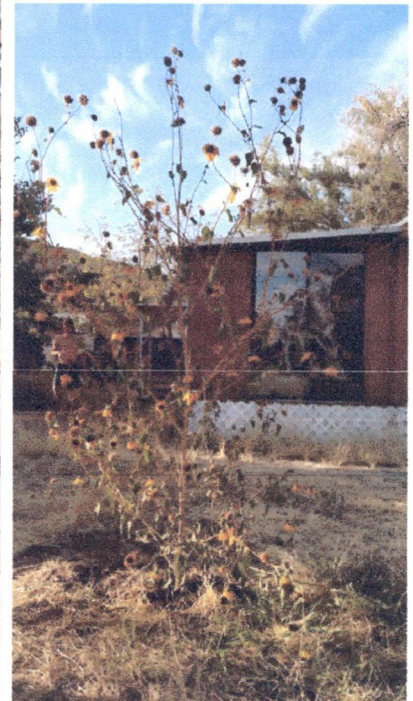

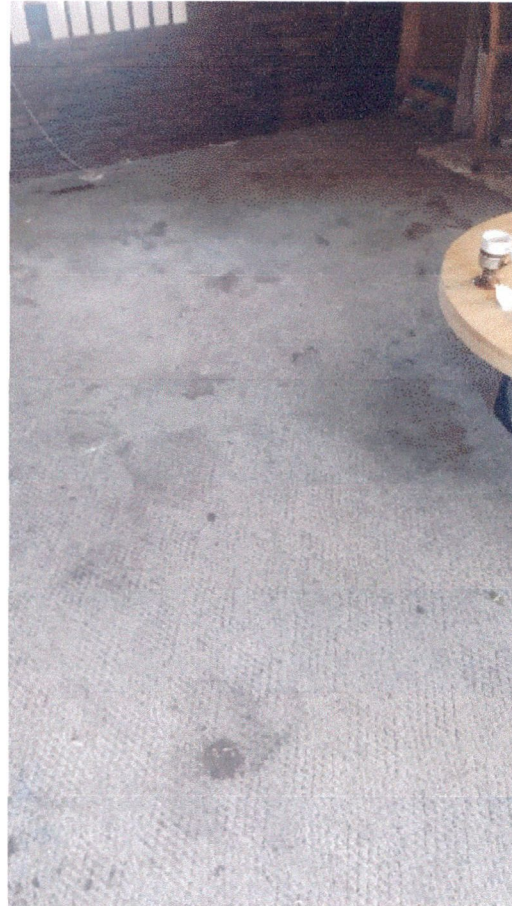

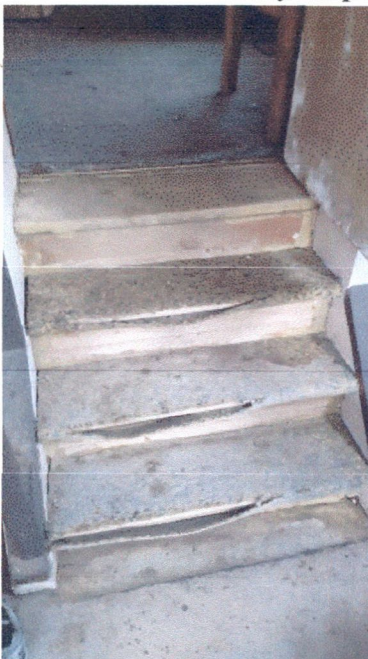

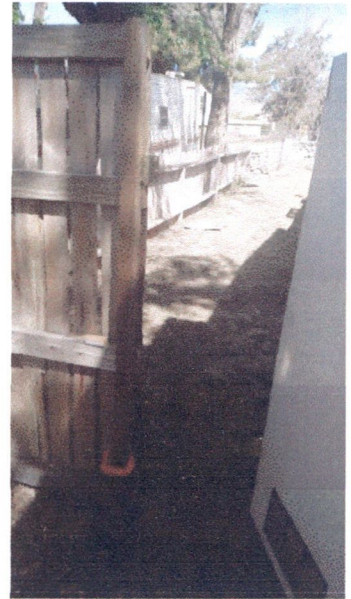

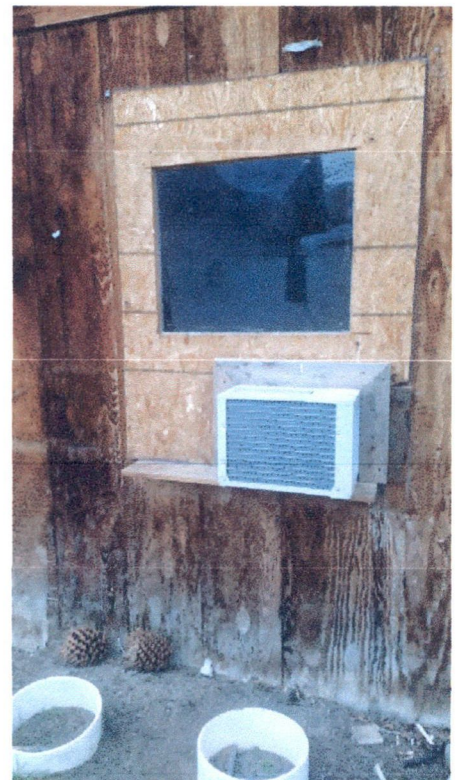

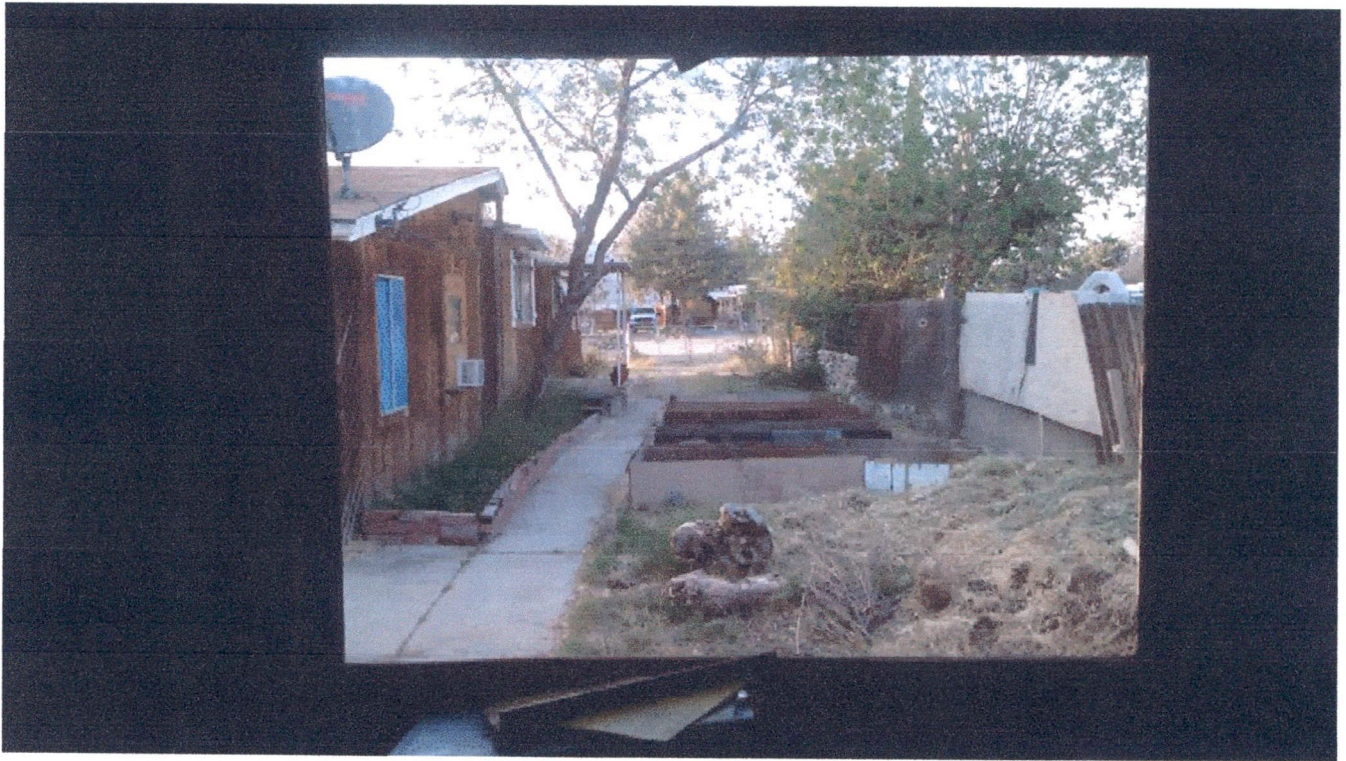

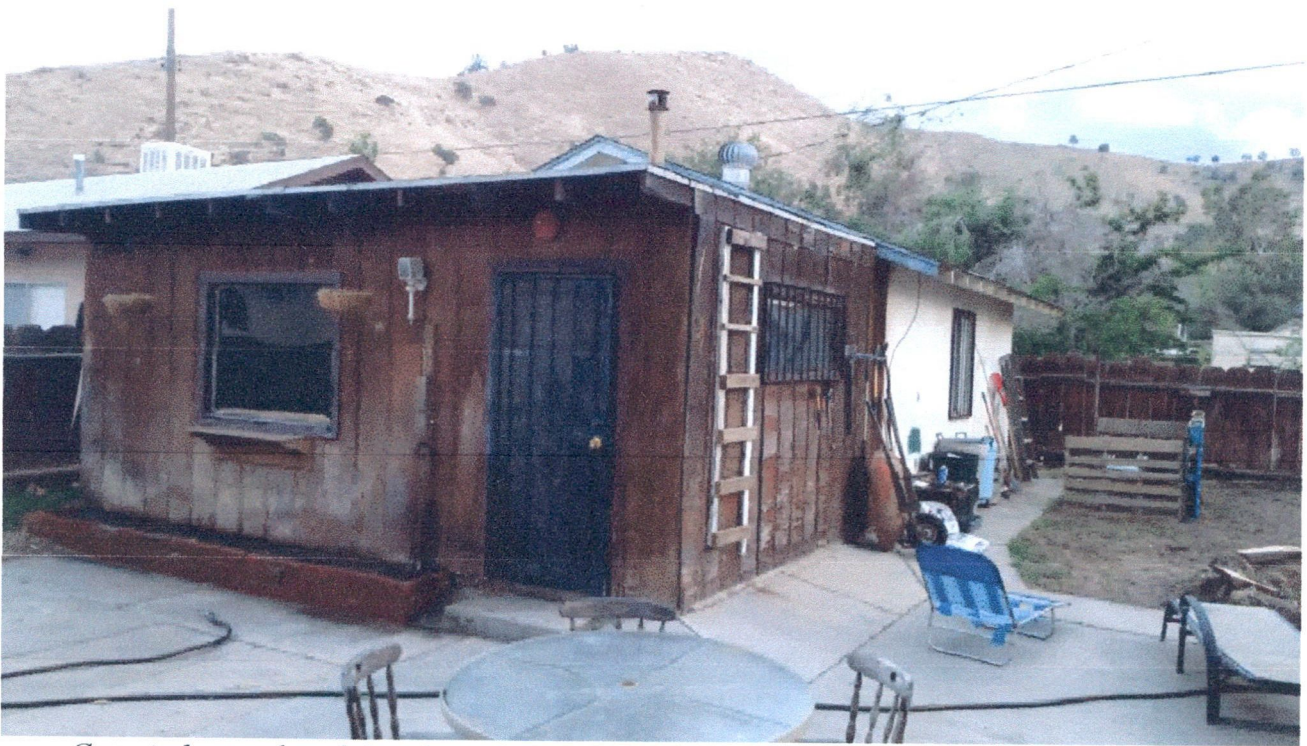

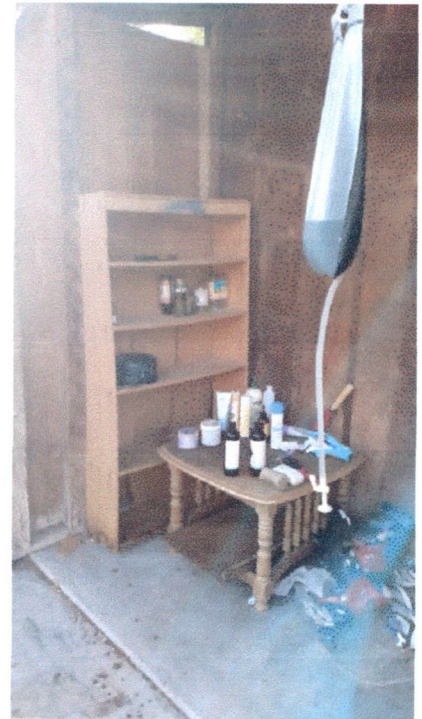

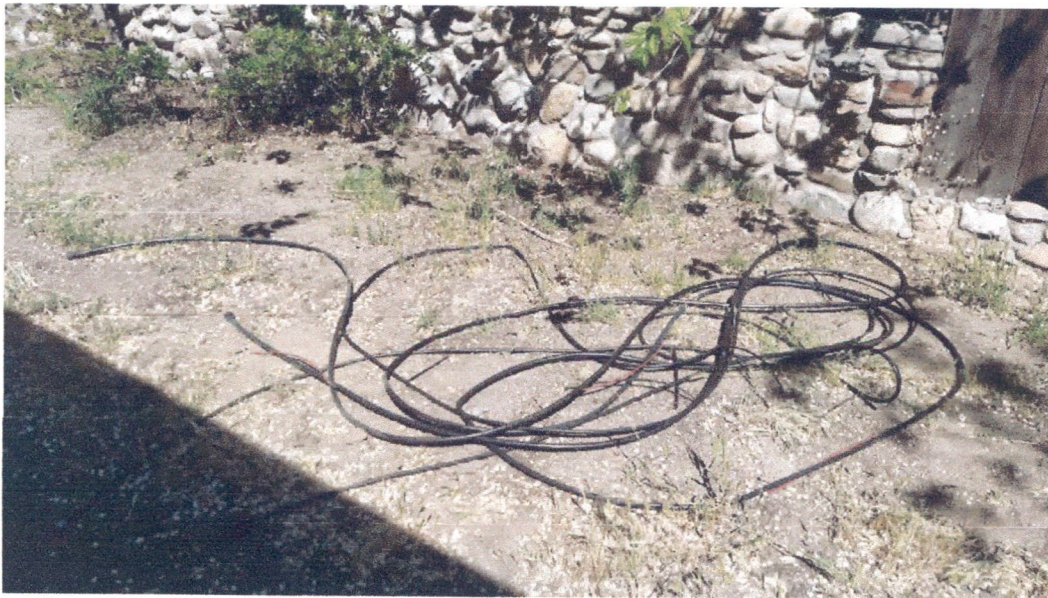
