I did already order the docket from the Clerk of Court: they didn't seem to have any additional documentation regarding this case. I attached a copy of what they gave me.

Within the docket you can see where Gordon Allen references a plea agreement which isn't shown anywhere in the docket. Somehow, within that plea agreement, it was arranged that the City of Ames would write an apology letter and give me a \$1500 check. I don't see any documentation of that, but it looks like there is paperwork between Gordon and the State Attorney (or Cty. Atty) wherein they outlined a plea agreement. When I contacted the City of Ames about this, the City Atty told me it was handled by the County Attorney's Office, so I presume they have a copy of the referenced agreement.

Would you mind checking and seeing, or should I ask the County Attorney's Office directly?
