Dear Officer Schieffer:

I would like to see Lyndsay Nissen (CEO of Reliable Street in west Ames, and works with Love Club LLC who owns the property) and Charlie Esker (has or had an art studio provided to them by Reliable Street, and sells are there) arrested on fraud charges for violation of [Iowa Code §714.8](#), which states that any person who “**makes any entry in... any public records... knowing the same to be false,**” is guilty of fraud.

In response to the complaint I filed with the Iowa Civil Rights Commission (ICRC) against Reliable Street, Love Club, and Lockwood Cafe, Nissen and Esker wrote approximately ten false, defamatory statements about me to the ICRC in order to deceive them and persuade them to drop the case.

Within this article, under section 5 you will find several pieces of evidence demonstrating that Nissen and Esker made entries into a public record, knowing those entries to be false - thus violating Iowa's fraud statute: <https://wildwillpower.org/cases-in-progress/iowa-cases/transgender-woman-claims-a-501c3-reliable-street-retaliated-against-her-for-filing-a-civil-rights-complaint-against-them>

Note that records generated by the Iowa Civil Rights Commission are "public records" defined in Section 22.1(3) unless otherwise excluded. [1]

Also note that “Public records” includes all records, documents, tape, or other information, stored or preserved in any medium, of or belonging to this state or any county, city, township, school corporation, political subdivision, nonprofit corporation... or tax-supported district in this state, or any branch, department, board, bureau, commission, council, or committee of any of the foregoing." [2]

I am willing to testify under penalty of perjury that Esker and Nissen entered false entries into the public record, and there are multiple witnesses who would also testify.

I can provide additional evidence if you have questions, and I am concerned that some parties may lie to try to protect these two.

I would like Ames Police to investigate this matter.
