Public Notice, Release, and Call to Action: This is an extremely important email being sent out due to national and statewide crisis. It is crucial that any regulations, policies, etc. which might impede this legitimate First Amendment activity be suspected, lest 18 USC Sec. 242 be violated. It is requested that this email be forwarded to any and all media, religious organization, nonprofits, individual, government official, Representative, Senator, journalist, talk show host, and anyone else who might possibly be interested. If someone will please deliver a copy of this to the U.S. Attorney's Office inside the Neal Smith Building, then send confirmation, that would be appreciated and needed. They don't have an email address, and have not responded to calls yet.

It is not okay and violates The Preamble of the [U.S. Constitution](#) and [Galatians 5:14](#) aka The One Commandment. Make sure Brett Barker sees this, and I sincerely would like to see public apologies and for all of you who are anti-LGBT+ to start asking questions instead of making harmful judgments and allegations. When I think of what so many Republicans have been doing, I am reminded of Jesus's words, "Forgive them, Creator, for they know not what they do." Due to the harm, fear, and anxiety ya'll have racketed, I trust you will alert any and all persons involved with the REPUBLICAN PARTY OF IOWA and/or REPUBLICAN NATIONAL COMMITTEE that this message exists. Instead of continuing to conspire, defraud, and violate the U.S. Constitution, I trust in THE LORD that you will all begin strategizing on how to heal this mess that people within your racketeering-influenced corrupt organizations will begin healing. II. What this is about

At 9:00 a.m. on March 31 organizers will gather in front of the [US Attorney's Office](#), located on federal property adjacent to Des Moines. I do not know how many people will show up, but it is possible there will be a very long line formed by 10:00 am which may trail outside federal property, into Des Moines and therefore other jurisdictions. Volunteers, accompanied by Notaries Public, will assist Participants in getting their affidavits signed for the Criminal Complaint I am currently drafting, so that they may be filed and we may exercise our inalienable Due Process rights.

Many Participants, including myself, are victims to the crimes alleged; Iowa and United States Citizen, let no attorney or pundit sway your doubt in this right: several of the statutes referenced evidence the fact that there is federal jurisdiction within the state, lest the criminals themselves will not hold themselves accountable to federal law. State of Iowa officials involved skirted the law and denied me redress last year in the state courts for case [LACL157953.](#), which may be found inside the EDMS portal. State attorneys appeared more interested in protecting those who would harm transgender lowans, or remaining neutral due to, perhaps, a conflict of interest or fear that their reputations might be marred for representing something many consider "political" even though it is just about rights violations, discrimination, and equal protections of the law.

All information about [the Call to Action is located here](#), and what isn't written yet will be peaceably assembled onto the web page asap, as I am moving as swiftly as physically able. Trust: I possess the knowledge, and when it is imparted, everyone will.

III. Request to Law Enforcement Agencies, Attorneys, Lawyers, et al

Please keep us safe. If you personally or anyone involved may have conflicting beliefs about LGBT+ due to what might be written in religious texts, I beg you to remember The One Commandment, Galatians 5:14, "For the entire Law is fulfilled by this One Command: You shall Love thy neighbor as thyself."

That said, it is hoped, in a "worst case scenario", that this becomes a second Magna Carta moment; for example, if Kim Reynolds, Donald Trump, and/or anyone else enters anything into the chain of command which might potentially harm (including violating rights) of Participants, such order, we do hereby request, with due diligence, be ignored, and The People be protected against such wrongdoing. If this is accomplished, we shall change the world.

If, on the other hand, Donald Trump and/or Kim Reynolds shows up (they have been requested to be there, and have received copies of the attached fliers with the message "Please be there" written on the back of the flier) and Officers are commanded not to make any arrest, please note that Iowa Code Sec. 804.24 authorizes me to make a Citizen's Arrest. I also have the right to make a Citizen's Arrest according to constitutional common law. I will be unarmed with a set of handcuffs, and processing paperwork so that everything may be done by the books. In the event such type of arrest must take place, I request that I am kept safe, and that if you are ordered and/or compelled to stop or tackle me, to instead make the arrests of the appropriate parties, which is not me.

I will be continue praying to the Creator for this Call to Action to go as planned.

IV. Request for Help

Please help spread the word via forwarding this email to everyone, including any and all Executive Personnel who might be there. If any regulation, etc, prevents you from forwarding this to Executive Personnel, send it to the natural person's private email - to them as a Citizen, that they might hear this vital news, and know what is to be done.


