COMES NOW the Petitioner, Sondra Wilson, *pro se*, pursuant to the Constitution of the United States while in the free exercise of my inalienable right to due process and all other applicable and potentially-applicable rights:

- (I) NOTICE OF SUIT AT EQUITY, LAW, AND PROSECUTION,
- (II) DIRECTIVES GOVERNING THIS SUIT,
- (III) MOTION TO JOINDER.
- (IV) EXTRAORDINARY SUMMONS WITH OFFER TO PLEA BARGAIN, and, in the alternative, MOTION TO ISSUE ARREST WARRANTS WITH NO PLEA BARGAIN, PENALTIES, and FEES; and
- (V) <u>URGENT</u> MOTION FOR EXTRAORDINARY WRIT

I. NOTICE OF SUIT AT EQUITY, LAW, AND PROSECUTION

1. My name is Sondra Wilson, drafter of the Original and forthcoming Amended Petition(s) and related Criminal Complaint that was filed, immediately previous to filing the Petition, with the U.S. Attorney's Office for the Southern District of Iowa on March 31, 2025 (Transgender Day of Visibility). You are hereby Notified that this Suit, case # 4:25-cv-00116-SHL-WPK, which the Court hath named "Wilson et al v. Trump et al", has been filed.

Why are you getting this?

2. A Suit at Equity and Law (see attached Petition), and a Criminal Complaint (see attached Complaint), has been filed against you, or the entity you represent, in this Court under the number shown above. A copy of the Petition and Complaint is attached. A Summons is attached, with costs incurred courtesy of myself, presuming the attached Urgent Extraordinary Writ be granted, and presuming you appear in the manner as directed within the Summons, lest penalties and fees be incurred upon you.

You have two options:

Option #1

3. Within 30 days of the receipt of this Notice (or 60 days if the defendant is outside any judicial district of the United States), go to 123 East Walnut Street, Des Moines, IA 50309 (or file via PACER.gov) and file a Notice with the Court which states the following, "I shall appear in line, in an orderly manner, in front of Parks Library, within the Free Speech Zone, on the Iowa State University campus (Ames, Iowa) at 11:00 am, on July 4, 2025. I shall be unarmed, without malice and without accomplices, with my insignia off and unclothed in the Power of the State, in order to peaceably accept my arrest so that Petitioner-Plaintiffs' inalienable, unconditional rights to due process may be exercised. I am aware that Sondra Wilson has an unconditional prescriptive right to perform a Citizen's Arrest pursuant to Iowa Code 804.24 and American Constitutional Common Law. I am aware that any action taken to prevent, hinder, or delay the execution of any law of the United States is a violation of 18 U.S. Code § 2384 - Seditious conspiracy"

Option #2

4. If you do file the aforedescribed Notice with the Court within the time indicated, a Warrant shall be issued for your arrest along with corresponding penalties (e.g. fines and increased prison time) and inconvenience fees which I have otherwise waived as a courtesy to you. I certify that I shall hand-deliver this Notice to the majority of named defendants on the date indicated near the bottom of this document via entering into the rooms where the Legislative Assemblies for the STATE OF IOWA take place (inside the "Iowa State Capitol" building), and that I shall work diligently and expediently to serve all other parties.

II. DIRECTIVES GOVERNING THIS SUIT

5. Henceforth, it is likely I who shall be addressing the Court on behalf and in favor of Petitioner-Plaintiffs, however other Interested Parties¹ are of course certainly free to do so. It is possible that an Authorized Representative, however, shall accept this case; such a person(s), with whom I do fully trust, has not yet stepped forth and made themselves known to me. I shall continue to put forth my best effort to keep everyone fully informed with regard to the progress and developments pertaining to this case and surrounding issues via the website of an organization I founded called Wild Willpower PAC; see "Operation: Magna Carta II" here: https://wildwillpower.org/events-2/spring-summer-2025-operation-magna-carta-ii. Furthermore, I intend to redact all names and contact information for any and all Petitioner-Plaintiffs in the interest of their personal privacy and safety. To alleviate burden unto me and for safety of other Petitioner-Plaintiffs, I request the Court provide redacted copies of any and all filings which contain such names and contact information.

WHEREAS the State of Iowa, other states, local jurisdictions, and the United States are in a de facto "State of Emergency" caused by en masse de facto and in flagrante delicto rights violations, which have been and/or are currently being threatened against Multiple Classes of Persons "Petitioner-Plaintiffs" by named Defendants and yet unnamed Defendants ("co-conspirators"); Petitioner-Plaintiffs shall include, but may not be limited to, the following:

• "Homeless Persons" who have been wrongly threatened, ticketed, and/or arrested, etc. for "camping within city limits" and similar "Homeless Harassment Laws": "camping" is a commercial term, and impacted Homeless Persons have not been "camping" per se, but rather they have been put into undue survival situations caused largely by ecological

- decimation and lack of pro-active consideration with regard to their plights. I am in fact an injured party and therefore a Member of the Homeless Persons class;
- "Transgender Persons" who may be experiencing fear caused by direct and indirect threat(s), emotional pain and suffering, anxiety, mental anguish, stress, loss of necessary medical services in direct violation of the Medicare and Medicaid Act thereby causing legal injury (violation of Ninth Amendment right), and other torts to be specified in forthcoming Amended Petition(s);
- "Duressed Persons" includes any person experiencing and/or who has experienced undue influence, duress, coercion, and/or direct and/or indirect threats of job loss, and/or actual job loss, as a result of utilizing and/or seeking to utilize their First Amendment right and/or other rights, etc.:
- "Persons with Abortion Rights" includes any person who may choose, via joining this Suit, to overtly object to the loss of their Court-affirmed right to abortion,² which is guaranteed by the Ninth Amendment; this Suit was commenced within the limitations period of Dobbs v. Jackson Women's Health Organization, 597 U.S. 215 (2022). Note that, although many people have very strong beliefs regarding the life of the fetus, such is inconsequential with regard to the violation against other peoples' rights: forcibly violating such rights is no different than someone who believes very strongly about the sanctity of life and/or the rights of animals ripping a hamburger out of someone else's mouth, so to speak.

WHEREAS I do not have time right now to untangle the Federal Rules of (Criminal and Civil) Procedures or Federal Rules of Evidence "Rules". Therefore this filing is being performed without reference to such Rules, and instead is filed and ought be interpreted in accordance with the American Constitutional Common Law, with all Prescriptive Rights guaranteed by the Ninth Amendment, including those adopted into the U.S. legal system via Anglo-Saxon Common law, fully intact and at large. I shall perform all filings, arguments, etc. to the best of my knowledge, ability, and understanding, and shall continue to perform research and seek Counsel as able. If the Court requires me to make future filings pursuant to the Rules, then I shall require time to untangle and interpret the Rules in a similar manner with which I began to untangle the Iowa

I request the Court to take notice of the fact that I invested many years compiling and interlinking thousands of legal term definitions, using credible sources, throughout an in-the-making website, www.ReUniteTheStates.org: the compiling of such definitions is not dissimilar, and in fact is a continuance upon, the noble and renown efforts of a Friend of the Court, Henry Campbell Black (October 17, 1860 - March 19, 1927). Therefore, although I have not received an Honorary Law Degree, as he did, I do, in fact, appear to be qualified via years of rigorous study toward causes which are within Local, State, National, and International Public Interest ("Public Interest"). I request the Court take notice of the fact that I am in fact qualified to manage this Suit, including Authorized Representation of any and all injured parties. For the sake of expedient administration of justice, I request support from Officers of the Court in assisting with managing this complex case, including but not limited to assistance with funding any and all efforts in relation hereto, such as notifying the public, gathering and verifying testimonies, records checks, and so on. "The people of these United States are the rightful masters of both congresses and courts, not to overthrow the Constitution, but to overthrow the men who pervert that Constitution." - Abraham Lincoln;

WHEREAS in many cases throughout the history of the Courts, persons have argued the Letter of the Law without regard to the Spirit (justice) of the Law; injustice has often resulted. Therefore be aware: the Spirit of the Law Doctrine is in effect throughout the duration of this case and beyond. Forgive and disregard, if necessary, any imperfections within this filing and all others: priority of expedience has necessarily overridden perfection, and frankly, we are human. The

Spirit of the Law Doctrine shall override the Letter, wherever and whenever conflict may arise, should any such instance(s) occur;

WHEREAS the urgent nature of these matters caused by the State of Emergency the Defendants, including those yet unnamed, have put our state, nation, local governments, international allies, and The People therein into, I request, and in fact respectfully and reasonably demand, that the attached Urgent Extraordinary Writ be granted in its entirety so that this Notice of Suit, Joinder, Summons, and Alternative Motion to Issue Arrest Warrants may be expediently served upon the Defendants. Due to the fact that shenanigans by various Parties led to injustice resulting within the State of Iowa's Courts, including evasion of process by KIM REYNOLDS FOR IOWA, who shall be named in the forthcoming Amended Petition, I must enter into the State of Iowa's Capitol building today, or no later than 4/15/2025, to personally serve the majority of the Defendants. No justice was served as a result of my filing of case # LACL157953 within the State of Iowa's Court system; this Suit is a continuation and expansion thereof, and resulted from "overt acts of furtherance" of the conspiracy described therein;

WHEREAS the Suit and Criminal Complaint were filed against natural persons and not against their Titles and/or Roles, etc.,

- 1. Trump v. United States, 603 U.S. ___ (2024) does not apply;
- 2. Wherever and however reasonably possible, I cannot serve Defendants through the Power of the State; therefore I cannot simply place this document into Legislative mailboxes within the Iowa State Capitol. I must hand it to them personally or personally witness the document entering into the natural hands of each Defendant;

THEREPORE I request the Court take notice of all aforementioned facts and considerations, and thereby:

- Stamp and certify this Notice and Summons, and Alternative Summons so that this
 document and any corresponding Court Order may be served at 3:33 p.m. today (or
 tomorrow, only if necessary) in the manner described herein;
- 2. Grant an Extraordinary Writ as described herein:

FURTHERMORE due to the fact that I live in a vehicle and have suffered poverty and severe distress for many years, largely caused by numerous acts of defamation and incitement of harassment against transgender women – to which I have personally suffered on more times than I can count – and due to the severe PTSD I am diagnosed with, caused largely by numerous acts of violence and sexual assault to which I have personally suffered – I request the Court to provide printed copies of this document so that I may pick them up from the Court in order to serve them in the manner described within (V) Urgent Motion for Extraordinary Writ.

III. MOTION TO JOINDER

6. For the sake of expediency and to reduce burden on the Court and myself, and to reduce the risk of a federal prosecutor being fired and/or facing undue influence, corruption, etc, I move for proceedings for this case and the case pertaining to Attachment B (Criminal Complaint) to be joined, and to then litigate both the criminal and civil aspects with regard to this case (for causes of actions and governing statutes are similar if not the same).

IV. EXTRAORDINARY SUMMONS WITH OFFER FOR PLEA BARGAIN or, in the alternative, MOTION TO ISSUE ARREST WARRANTS WITH NO PLEA BARGAIN, PENALTIES AND FEES

7. All Defendants must notify the Court and appear in the time, place, and manner described within paragraph 3. Any and all named Defendants who do not perform these actions shall face repercussions described in paragraph 4.

V. <u>URGENT</u> MOTION FOR EXTRAORDINARY WRIT and WAIVER OF PRINTING COSTS AND FEES

- 8. I move for the Court to grant an Extraordinary Writ which commands/instructs the following the following to the following parties, and to make any other necessary arrangements necessary and lawful:
 - To the Clerk of Court: print 100 copies of the Original Petition and Criminal
 Complaint, with names of Petitioners, Witnesses, and Victims redacted, and 100
 copies of this document and any corresponding Court Order(s) [e.g.
 Injunction(s)], to be made available for me to pick up so that service may be
 provided. Due to the fact that I am impoverished and continue to suffer mentally
 and emotionally, and with continuing injuries to my rights caused by the
 Defendants, I move for printing costs and any fees to be waived;
 - 2. To the Iowa Department of Public Safety (dpsinfo@dps.state.ia.us): Upon entering into the State of Iowa Capitol building, or upon entering onto the property thereof, Sondra Wilson shall be safely and respectfully escorted to the rooms where the Legislative Assemblies take place, and to the room where Kim

Reynolds is located, so that she may safely and respectfully serve process to the Defendants. Ms. Wilson shall call out names and request named parties to raise hands so that process may be expediently served. This MUST happen today or tomorrow because tomorrow is the last day of the Legislative Session, meaning it will be too difficult and expensive to serve process after that. Additionally, I sewed this clothing specifically for this so that I may effectively convey the message that needs to be conveyed: wearing this gear (and the cloak, not shown) is the only way I can accurately send the message.



3. <u>To any and all News Agencies</u>: this entire process should be filmed and broadcast truthfully and honestly.
