Pursuant to Iowa Code of Judicial Conduct Rule 51:2.11(A), I, Sondra Wilson, file this Motion for Her Honorable Judge Samantha Gronewald to Recuse herself from this action.

In light of Deputy Adamovic's statement within his May 13 Return of Service, I request acceptance of service to be acknowledged on behalf of Kim Reynolds for Iowa.

Due to the fact that I am currently involved in a lawsuit (case# LACV053674) which directly relates to this lawsuit, pursuant to Iowa Rule of Civil Procedure 1.911(1), I file this Motion to Continue.

**Motion to Recuse**

1. Governor Kim Reynolds appointed Judge Samantha Gronewald I December 2017.
2. Governor Reynolds and Kim Reynolds for Iowa, her campaign committee, are named in this lawsuit.
3. On March 31 this year, I filed a complaint against Judge Gronewald with the Iowa Judicial Qualifications Commission because she did not recuse herself from case # LACL157381, as required by Iowa Code of Judicial Conduct Rule 51:2.11(A). I recently received a letter from the Commission that they will be reviewing my complaint within their upcoming meeting.
4. Iowa Code of Judicial Conduct Rule 51:2.11(A) sets forth, "A judge shall disqualify himself or herself in any proceeding in which the judge's impartiality might reasonably be

questioned....”

5. Your Honor, with good reason I question your impartiality with regard to this case, and request you to recuse yourself.

**Request for Acceptance of Service**

6. Within Deputy Adamovic's May 13 Return of Service, he stated, “I spoke with legal staff for the Governor over the phone and they advise that they do not accept service on behalf of Kim Reynolds for Iowa (Campaign). Any services for the Governor need to be served on the Attorney General on the Governor's behalf.”

7. I contacted the Secretary of State's Office and was informed that the registered address for Kim Reynolds for Iowa is as follows:

8. Due to the fact that I am unable to locate where Original Notice ought be served on Kim Reynolds for Iowa, and because the Iowa Attorney General may easily locate and provide a copy of my Petition to Governor Reynolds, I am requesting that the Attorney General do so for the sake of expediency and convenience, and for Kim Reynolds for Iowa to accept service.

9. In the alternative, I request a proper address for which Kim Reynolds for Iowa may be served.

**Motion to Continue**

10. I am currently planning to resist the State of Iowa's Motion to Dismiss, however I am currently involved in case # LACV053674, which contains matters which directly involve this case.

11. Between case # LACV053674 and this case, I am currently feeling overwhelmed with case work. I got both cases filed on within the limitations periods, but only feel capable of focusing on one at a time.

12. I move to postpone this case until after case # LACV053674 is resolved, or at least until that case is moved forward. I request additional time before submitting a resistance to the

State's Motion to Dismiss, and move to postpone the June 16 hearing until July
